**AN ORDINANCE AMENDING, RESTATING AND READOPTING
ARTICLES III OF CHAPTER 26, ELECTIONS
OF THE NEW KENT COUNTY CODE
TO CHANGE THE NAME AND LOCATION
OF ONE VOTING PRECINCT**

WHEREAS, Section §24.2-300, *et. seq.* of the Code of Virginia requires the governing body of any county to establish precincts for its locality; and

WHEREAS, by adoption of Ordinance O-08-11, the New Kent County Board of Supervisors established the ten named precincts as well as the locations of the polling places; and

WHEREAS, the New Kent County Board of Supervisors has been requested by the Electoral Board to change the location of the Airport Precinct and rename it as the Mountcastle Precinct (MC);

NOW THEREFORE BE IT ORDAINED that Article III of *Chapter 26, Elections* of the New Kent County Code be and are hereby amended, restated and readopted as set forth below:

ARTICLE III. PRECINCTS; POLLING PLACES

Sec. 26-71. Article establishes precincts and polling places.

Pursuant to authority contained in Code of Virginia §§ 24.2-305 et seq., the precincts and respective polling places in this county are hereby created and established as set forth in this article.

Sec. 26-72. Designation of precincts and polling places in each election district.


Sec. 26-74. Notification to voters affected by change of magisterial district, precinct or polling place.

The secretary of the electoral board shall notify by mail no later than 15 days prior to the next general, special or primary election all registered voters whose magisterial district, precinct or polling place has been changed subsequent to the last general, special or primary election.


