Motion was made by Mr. Tiller, which carried 5:0, to adopt the following ordinance:

**AN ORDINANCE AMENDING, RESTATING AND READOPTING
SECTION 26-73 OF THE NEW KENT COUNTY CODE TO ESTABLISH THE
CENTRAL ABSENTEE VOTING DISTRICT
IN THE DESIGNATED MEETING ROOM AT 7911 COURTHOUSE WAY
AND REPEAL THE PREVIOUSLY ESTABLISHED
CENTRAL ABSENTEE VOTING DISTRICT
IN THE OLD COURTROOM IN THE OLD
NEW KENT COUNTY COURTHOUSE AT 12003 NEW KENT HIGHWAY**

WHEREAS, the Board of Supervisors, in an effort to save money and utilize county office space efficiently, has voted to move the General Registrar/Voter Registration Office to Suite 400 in the Health and Human Services Building located at 7911 Courthouse Way, New Kent, Virginia; and

WHEREAS, the Board desires to keep the Central Absentee Voting District and the General Registrar/Voter Registration Office in the same location; and

WHEREAS, at its meeting on July 25, 2013, the New Kent County Electoral Board voted unanimously to move the central absentee voting precinct to the said designated Meeting Room in the Health and Human Services Building;

NOW THEREFORE BE IT ORDAINED by the New Kent County Board of Supervisors, pursuant to the authority and procedures contained in section §24.2-712 of the Code of Virginia, 1950 (as amended), that the central absentee voting precinct is hereby discontinued in the Courtroom of the Old Courthouse located at 12003 New Kent Highway and established in the designated Meeting Room at the Health and Human Services Building located at 7911 Courthouse Way, New Kent, Virginia, 23124, and that Chapter 26, Article III of the New Kent County Code be amended, restated and readopted as follows:


Sec. 26-73. Central absentee voting precinct.

Within the central absentee voting district, the polling place for the central absentee voting precinct shall be ~~the Old Courtroom in the Old New Kent County Courthouse, 12003 New Kent Highway,~~ **the designated Meeting Room in the Health and Human Services Building at 7911 Courthouse Way,** New Kent, Virginia, 23124-0128.

This Ordinance shall take effect immediately and shall apply to the November 5, 2013 General Election.
