Motion was made by Mr. Tiller, which carried 5:0, to adopt the following ordinance:

**AN ORDINANCE AMENDING CHAPTER 66, TAXATION, ARTICLE I,
IN GENERAL, SECTION 66-4, PAYMENT OF TAXES, FEES, OR OTHER
CHARGES BY CREDIT CARD, SERVICE CHARGE**

WHEREAS, the General Assembly has enacted certain changes to the Code of Virginia which require amendments to the New Kent County Code relating to the acceptance of revenue by commercially acceptable means as well as service and bad check charges; and

WHEREAS, pursuant to Virginia Code Section §2.2-614.1, the New Kent County Board of Supervisors has authority to amend Chapter 66, Article I of the County Code; and

WHEREAS, the Board finds that it is in the interest of the County and its citizens to amend the taxation provisions pursuant to the changes enacted to Virginia Code Section §2.2-614.1; and

WHEREAS, the Board has provided notice and held a public hearing pursuant to the Code of Virginia;

NOW, THEREFORE BE IT RESOLVED, on this 12th day of August, 2013, the New Kent County Board of Supervisors hereby amends Chapter 66, Taxation, Article I, In

General, Sec. 66-4, Payment of Taxes, Fees, Or Other Charges by Credit Card, Service Charge, as set forth below:

Sec. 66-4. — Payment of taxes, fees or other charges by credit card; service charge.

~~Any local taxes authorized and imposed by this chapter may be paid by use of a credit card approved by the treasurer. When accepting credit card payments, the treasurer shall, in addition to any penalties and interest arising pursuant to Code of Virginia, §§ 58.1-3915 — 58.1-3918, add to such payment a sum not to exceed four percent of the amount of tax, penalty and interest paid, or \$6.00, whichever is greater, as a service charge for the acceptance of such card. Such service charge shall not exceed the amount charged to the county by the credit card company.~~

Sec. 66-4. - Payment of taxes by credit card.

Pursuant to the authority of Code of Virginia, §2.2-614.1, the treasurer may accept payment of local taxes, fees, and charges by use of a credit card. The treasurer may levy a service charge not to exceed the actual fee charged to New Kent County by the bank or financial institution processing the payment.


