Motion was made by Mr. Sparks, which carried 5:0, to adopt the following resolution:

**A RESOLUTION FOR THE APPROVAL  
OF THE ADDITION OF TAX MAP PARCEL  
47-1 TO THE YORK RIVER AND TAX MAP PARCELS  
36-10, 45-1 and 45-2 TO THE TIMBER SWAMP  
AGRICULTURAL AND FORESTAL DISTRICTS**

WHEREAS, Betty L. Johnson & Lynne J. Fischer have applied to add tax map parcels 47-1, GPIN #(s) F31-1719-1606, containing approximately 78 acres to the York River Agricultural and Forestals District; and

Whereas, Betty L. Johnson & Lynne F. Fischer have applied to add tax map parcels 36-10, 45-1, 45-2, GPIN #s F25-0349-4588, (45-1 and 45-2 do not currently have a gpin), totaling approximately 190 acres to the Timber Swamp Agricultural and Forestal District; and

WHEREAS, granting this request will increase the acreage of the York River Agricultural and Forestal District from approximately 2,813 acres to approximately 2,891 acres, and

WHEREAS, granting this request will increase the acreage of the Timber Swamp Agricultural and Forestal District from approximately 237 acres to approximately 427 acres; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, the Agricultural and Forestal District Advisory Committee voted 7:0:1 to forward a favorable recommendation of this application; and


WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing in accordance with the applicable requirements of the Code of Virginia, carefully considering the public comment received; and


WHEREAS, after conducting a duly advertised public hearing in accordance with the applicable requirements of the Code of Virginia voted 10:0:1 to forward the request with a favorable recommendation; and

WHEREAS, this application has been advertised for public hearing before the Board of Supervisors in full accordance with the applicable provisions of the Code of Virginia, and

NOW THEREFORE BE IT RESOLVED this the 8th day of August, 2011, by the New Kent County Board of Supervisors, the addition of tax map parcel 47-1, GPIN # F31-1719-1606, containing approximately 78 acres to the York River Agricultural and Forestal District and tax map parcels 36-10, 45-1, 45-2, GPIN #s F25-0349-4588, (45-1 and 45-2 do not currently have a gpin) containing approximately 190 acres to the Timber Swamp Agricultural and Forestal District is hereby approved with the following conditions:

1. The applicant shall work with the Virginia Forestry Department to develop a forestry stewardship plan within one (1) year from the date of approval, or provide the Environmental Division Office with an equivalent plan for the forestal parcels.
