**A RESOLUTION RECOMMENDING APPROVAL
FOR THE RENEWAL OF THE AGRICULTURAL
AND FORESTAL DISTRICTS**

WHEREAS, the Agricultural and Forestal District Program has been reorganized to reduce the financial costs associated with the administration of the program; and

WHEREAS, the districts were realigned and renamed in 2010, reducing the number of districts from 25 to 19; and

WHEREAS, all of the districts are up for renewal for a period between four (4) and ten (10) years as outlined in state and county code; and

WHEREAS, this request is in accordance with state and county code governing Agricultural and Forestal Districts; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, the Agricultural and Forestal District Advisory Committee voted 7:0:1 to forward a favorable recommendation of the proposed renewal schedule; and




WHEREAS, this application has been advertised for public hearing before the Board of Supervisors in full accordance with the applicable provisions of the Code of Virginia, and
