Motion was made by Mr. Davis, which carried 5:0, to adopt the following resolution:

**A RESOLUTION TO APPROVE THE
WITHDRAWAL OF 1.041 ACRES
OF TAX MAP PARCEL 14-6
FROM THE COOKS MILL AGRICULTURAL
AND FORESTAL DISTRICT**

WHEREAS, Mr. Richard Potter has applied to withdraw 1.041 acres from the Cooks Mill Agricultural and Forestal District from tax map parcel 14-6, GPIN # L23-2140-4062, currently consisting of approximately 154.23 acres; and

WHEREAS, granting this request will leave the remaining 153.189 acres of parcel 14-6 in the Cooks Mill Agricultural and Forestal District; and

WHEREAS, the withdrawal request will not have an adverse impact on the agricultural operations on the remainder of the parcel; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and

WHEREAS, this application was forwarded to the Planning Commission by the Board of Supervisors on September 29, 2010; and

WHEREAS, this application was considered by the Agricultural and Forestal District Advisory Committee and forwarded with a favorable recommendation; and


WHEREAS, this application was thoroughly considered by the Planning Commission on October 18, 2010; and


WHEREAS, after conducting a duly advertised public hearing in accordance with the applicable requirements of the Code of Virginia the Planning Commission voted 6:0:1 to forward the request with a favorable recommendation; and

WHEREAS, this application has been advertised for public hearing before the Board of Supervisors in full accordance with the applicable provisions of the Code of Virginia;

NOW THEREFORE BE IT RESOLVED, this the 10th day of November 2010, by the New Kent County Board of Supervisors, the withdrawal of 1.041 acres from the Cooks Mill Agricultural and Forestal District from Tax Map Parcel 14-6, GPIN # L23-2140-4062, as shown on the plat titled 'Boundary Line Adjustment-Lot Consolidation' prepared by David R, Gardy, dated September 9, 2010 for James Wills, Jr. and Kathleen Wills", is hereby approved.

BE IT FURTHER RESOLVED, the remaining 153.189 acres of Tax Map Parcel 14-6, GPIN # L23-2140-4062, remain in the Cooks Mill Agricultural and Forestal District.
