**A RESOLUTION TO REQUEST THE VIRGINIA  
DEPARTMENT OF TRANSPORTATION TO ADD  
SECTION L OF THE BRICKSHIRE SUBDIVISION  
INTO THE STATE SYSTEM FOR MAINTENANCE**

WHEREAS, Brickshire, Section L is referenced in deed book 328, page 609 in the Office of the Clerk of the Circuit Court of New Kent County; and

WHEREAS, the Resident Administrator for the Sandston Residency of the Virginia Department of Transportation has advised the Board that the streets listed herein meet the standards and requirements established by the *Subdivision Street Requirements* of the Virginia Department of Transportation for acceptance into the secondary system of state highways for maintenance; and

WHEREAS, the Board desires that the streets listed herein be accepted into the secondary system of state highways for maintenance purposes;


NOW THEREFORE BE IT RESOLVED this, the 8<sup>th</sup> day of June, 2009, by the New Kent County Board of Supervisors that the Virginia Department of Transportation be, and it is hereby, requested to add the following streets to the secondary system of state highways pursuant to section 33.1-229 of the *Code of Virginia* and the Department's *Subdivision Street Requirements*:


BE IT FURTHER RESOLVED that a certified copy of this Resolution be forwarded to the Sandston Resident Administrator for the Virginia Department of Transportation.
