**A RESOLUTION TO REQUEST THE VIRGINIA
DEPARTMENT OF TRANSPORTATION TO ADD
SECTION N, PHASE II OF THE BRICKSHIRE
SUBDIVISION INTO THE STATE SYSTEM FOR
MAINTENANCE**

WHEREAS, Brickshire, Section N, Phase II is referenced in deed book 417, page 960 in the Office of the Clerk of the Circuit Court of New Kent County; and

WHEREAS, the Resident Administrator for the Sandston Residency of the Virginia Department of Transportation has advised the Board that the streets listed herein meet the standards and requirements established by the *Subdivision Street Requirements* of the Virginia Department of Transportation for acceptance into the secondary system of state highways for maintenance; and

WHEREAS, the Board desires that the streets listed herein be accepted into the secondary system of state highways for maintenance purposes;

NOW THEREFORE BE IT RESOLVED this, the 13th day of July, 2009, by the New Kent County Board of Supervisors that the Virginia Department of Transportation be, and it is hereby, requested to add the following streets to the secondary system of


state highways pursuant to section 33.1-229 of the *Code of Virginia* and the Department's *Subdivision Street Requirements*:

Rock Wren Court, State Rte. 1256	From Rte.1255/Rock Wren Drive to cul- de-sac	0.20 miles	50 ft.
Kings Pond Drive, State Rte. 1147	From Rte. 1253/Sedge Wren Court to Rte. 1257/Harlequin Court	0.06 miles	50 ft.
Kings Pond Drive, State Rte. 1147	From Rte. 1257/Harlequin Court to cul- de-sac	0.07 miles	50 ft.
Harlequin Court, State Rte. 1257	From Rte.1147/Kings Pond Drive to cul-de-sac	0.05 miles	50 ft.


