**A RESOLUTION RECOMMENDING APPROVAL
FOR THE ADDITION OF TAX MAP PARCEL 31-10; 31-10-3,4,5,6,8,9
TO THE ASHLAND FARM AGRICULTURAL
AND FORESTAL DISTRICT**

WHEREAS, Ruffin Farm LLC & Ruffin Development LLC have applied to add tax map parcel(s) 31-10; 31-10-3,4,5,6,8,9, GPIN #(s) I10-3363-0897, I11-0848-2128, I11-1076-1865, I11-1162-1526, I11-1575-1196, I11-1246-1101, I11-1102-0958 containing approximately 157 acres to the Ashland Farm Agricultural and Forestal District; and

WHEREAS, granting this request will increase the acreage of the Ashland Farm Agricultural and Forestal District to approximately 680 acres; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public hearing, the Agricultural and Forestal District Advisory Committee voted 6:0:1 to forward a FAVORABLE recommendation of this application; and


WHEREAS, the renewal of this district was thoroughly considered by the Planning Commission; and

WHEREAS, after conducting a duly advertised public meeting, the Planning Commission voted 9:0:1 to recommend approval of this application; and


WHEREAS, this application has been advertised for public hearing before the Board of Supervisors in full accordance with the applicable provisions of the Code of Virginia, and

NOW THEREFORE BE IT RESOLVED this the 10th day of August 2009 by the New Kent County Board of Supervisors that the addition of tax map parcel(s) 31-10; 31-10-3,4,5,6,8,9, GPIN #(s) I10-3363-0897, I11-0848-2128, I11-1076-1865, I11-1162-1526, I11-1575-1196, I11-1246-1101, I11-1102-0958, containing approximately 157 acres, to the Ashland Farm Agricultural and Forestal District is hereby approved with the following conditions:

1. The applicant shall work with the Virginia Forestry Department to development a forestry stewardship plan within six (6) months from the date of approval.
