**A RESOLUTION RECOMMENDING APPROVAL  
FOR THE ADDITION OF TAX MAP PARCELS 23-30, 69, 69A, 69B, 70,  
70A, 70B TO THE PELHAM SWAMP AGRICULTURAL  
AND FORESTAL DISTRICT**

WHEREAS, the Gayla Smith Harrison Estate has applied to add tax map parcel(s) 23-30, 69, 69A, 69B, 70, 70A, 70B, GPIN #(s) J16-3640-0954, I16-2813-4936, J16-3523-3426, J16-1992-2268, J17-2223-3547, K17-0352-0034, containing approximately 296.72 acres to the Pelham Swamp Agricultural and Forestal District; and

WHEREAS, granting this request will increase the acreage of the Pelham Swamp Agricultural and Forestal District to approximately 969.72 acres; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public hearing, the Agricultural and Forestal District Advisory Committee voted 6:0:1 to forward the

application with NO RECOMMENDATION due to an incomplete application and several pending land transfers; and


WHEREAS, the renewal of this district was thoroughly considered by the Planning Commission; and

WHEREAS, after conducting a duly advertised public meeting, the Planning Commission voted 9:0:1 to recommend approval of this application; and


WHEREAS, this application has been advertised for public hearing before the Board of Supervisors in full accordance with the applicable provisions of the Code of Virginia, and

NOW THEREFORE BE IT RESOLVED, this the 10th day of August 2009 by the New Kent County Board of Supervisors that the addition of tax map parcel(s) 23-30, 69, 69A, 69B, 70, 70A, 70B, GPIN #(s) J16-3640-0954, I16-2813-4936, J16-3523-3426, J16-1992-2268, J17-2223-3547, K17-0352-0034, containing approximately 296.72 acres to the Pelham Swamp Agricultural and Forestal District is hereby approved with the following conditions:

1. The applicant shall work with the Virginia Forestry Department to development a forestry stewardship plan within six (6) months from the date of approval.
