**A RESOLUTION RECOMMENDING THE RENEWAL
OF THE YORK RIVER AGRICULTURAL AND FORESTAL
DISTRICT**

WHEREAS, the York River Agricultural and Forestal District was established on August 19, 1989 for a ten year term and was last renewed on August 19, 1999; and

WHEREAS, the York River Agricultural and Forestal District term expires on August 19, 2009, and all of the current members have indicated that they wish to renew their membership in the district, with the exception of Mrs. White not renewing parcel Tax Map # 38-34, (GPIN I31-1702-1556) and Rose and Andrew Q. Pitts, Jr. not renewing parcel Tax Map #47-22, (GPIN F33-2896-0775); and

WHEREAS, the renewal of this district was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public meeting, the Agricultural and Forestal District Advisory Committee voted 6:0:1 to forward NO RECOMMENDATION for the renewal of this application; and

WHEREAS, the renewal of this district was thoroughly considered by the Planning Commission; and


WHEREAS, after conducting a duly advertised public meeting, the Planning Commission voted 9:0:1 to recommend approval of this application; and
