Motion was made by Mr. Trout, which carried 5:0, to adopt the following resolution:

**A RESOLUTION RECOMMENDING NOT TO RENEW THE HARRISON
AGRICULTURE AND FORESTAL DISTRICT AND TO ADD THE 3 ELIGIBLE
PARCELS 22-32 (K14-3420-4336), 22-38 (L14-3532-0948), 22-47
(L14-2400-2912) TO THE PELHAM SWAMP AGRICULTURE AND
FORESTAL DISTRICT**

WHEREAS, the Harrison Agricultural and Forestal District was last acted upon in 1999; and

WHEREAS, parcels 22-30 (K13-4076-5155) and 22-31 (L14-1299-1755), totaling 332 acres, are included in the Farms of New Kent PUD and not longer eligible for the AFD program; and

WHEREAS, the Harrison Agricultural and Forestal District term expires in 2009, and the current members have indicated that they wish to renew the 3 eligible parcels into an adjacent AFD; and

WHEREAS, the Harrison Agricultural and Forestal District currently consist of the following parcels; and


WHEREAS, the renewal of this district was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public meeting, the Agricultural and Forestal District Advisory Committee voted 6:0:1 to recommend NOT to renew the Harrison Agriculture and Forestal District and to add the 3 eligible parcels 22-32 (K14-3420-4336), 22-38 (L14-3532-0948), 22-47 (L14-2400-2912) to the Pelham Swamp AFD; and


WHEREAS, the renewal of this district was thoroughly considered by the Planning Commission; and

WHEREAS, after conducting a duly advertised public meeting, the Planning Commission voted 9:0:1 recommending NOT to renew the Harrison Agriculture and Forestal District and to add the 3 eligible parcels 22-32 (K14-3420-4336), 22-38 (L14-3532-0948), 22-47 (L14-2400-2912) to the Pelham Swamp AFD; and

NOW THEREFORE BE IT RESOLVED, this the 10th day of August 2009, by the New Kent County Board of Supervisors that the Harrison Agriculture and Forestal District NOT be renewed and to add the 3 eligible parcels 22-32 (K14-3420-4336), 22-38 (L14-3532-0948), 22-47 (L14-2400-2912) to the Pelham Swamp AFD.
