Motion was made by Mr. Sparks, which carried 5:0, to adopt the following resolution:

**A RESOLUTION RECOMMENDING APPROVAL  
FOR THE ADDITION OF TAX MAP PARCEL 38-12, 12B, 12C, 12E, 38-13  
TO THE YORK RIVER AGRICULTURAL  
AND FORESTAL DISTRICT**

WHEREAS, Mr. Robert Edward Armandt has applied to add tax map parcel(s) 38-12, 12B, 12C, 12E, 38-13, GPIN #(s) I32-0358-0212, I32-0767-0526, H32-0834-4732, H32-0671-4640, n/a containing approximately 25 acres to the York River Agricultural and Forestal District; and

WHEREAS, granting this request will increase the acreage of the York River Agricultural and Forestal District to approximately 1,450 acres; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public hearing, the Agricultural and Forestal District Advisory Committee voted 6:0:1 to forward a favorable recommendation of this application; and


WHEREAS, the renewal of this district was thoroughly considered by the Planning Commission; and

WHEREAS, after conducting a duly advertised public meeting, the Planning Commission voted 9:0:1 to recommend approval of this application; and

WHEREAS, this application has been advertised for public hearing before the Board of Supervisors in full accordance with the applicable provisions of the Code of Virginia, and


NOW THEREFORE BE IT RESOLVED this the 10th day of August 2009 by the New Kent County Board of Supervisors that the addition of tax map parcel(s) 38-12, 12B, 12C, 12E, 38-13, GPIN #(s) I32-0358-0212, I32-0767-0526, H32-0834-4732, H32-0671-4640, n/a, containing approximately 25 acres to the York River Agricultural and Forestal District is hereby approved with the following conditions:

1. The applicant shall work with the Virginia Forestry Department to development a forestry stewardship plan within six (6) months from the date of approval.
