**A RESOLUTION APPROVING APPLICATION 015-14  
FOR THE RE-CREATION OF THE  
PAMUNKEY RIVER AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, the Pamunkey River Agricultural and Forestal District was established August 9, 2010, for a ten-year term and currently contains 7,564 acres, of which 5,104 identified acres are being proposed; and

WHEREAS, the Pamunkey River Agricultural and Forestal District term expired August 31, 201, and most of the current members have indicated that they wish to renew their membership in the district; and


