**A RESOLUTION APPROVING APPLICATION AFD-016-14  
FOR THE RE-CREATION OF THE  
BIG SWAMP AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, the Big Swamp Agricultural and Forestal District was established August 9, 2010, for a ten-year term and currently contains 964 acres, of which 996 identified acres are being proposed; and

WHEREAS, the Big Swamp Agricultural and Forestal District term expired August 31, 2014, and most of the current members have indicated that they wish to renew their membership in the district; and


WHEREAS, the re-creation of this district was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and
