**A RESOLUTION APPROVING APPLICATION AFD-007-15
FOR THE RE-CREATION OF THE
HIGGINS SWAMP AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, the Higgins Swamp Agricultural and Forestal District was established August 9, 2010, for a five-year term and currently contains 688 acres, of which 642.7 identified acres are being proposed; and

WHEREAS, the Higgins Swamp Agricultural and Forestal District term expires August 31, 2015, and most of the current members have indicated that they wish to re-create their membership in the district; and

WHEREAS, the re-creation of this District was thoroughly considered by the Agricultural and Forestal Advisory Committee; and


