**A RESOLUTION APPROVING APPLICATION AFD-008-15  
FOR THE RE-CREATION OF THE  
PELHAM SWAMP AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, the Pelham Swamp Agricultural and Forestal District was established August 9, 2010, for a five year term and currently contains 1,985 acres, of which 1961.68 identified acres are being proposed; and

WHEREAS, the Pelham Swamp Agricultural and Forestal District term expires August 31, 2015, and most of the current members have indicated that they wish to re-create their membership in the district; and


WHEREAS, the re-creation of this District was thoroughly considered by the Agricultural and Forestal Advisory Committee; and
