**A RESOLUTION APPROVING APPLICATION AFD-009-15
FOR THE RE-CREATION OF THE
PUTNEY CREEK AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, the Putney Creek Agricultural and Forestal District was established August 9, 2010, for a five year term and currently contains 2,918 acres, of which 2,809.44 identified acres are being proposed; and

WHEREAS, the Putney Creek Agricultural and Forestal District term expires August 31, 2015, and most of the current members have indicated that they wish to re-create their membership in the district; and

WHEREAS, the re-creation of this District was thoroughly considered by the Agricultural and Forestal Advisory Committee; and


