Motion was made by Mr. Tiller, which carried 5:0, to adopt the following resolution:

**A RESOLUTION APPROVING APPLICATION AFD-009-16
FOR THE ADDITION OF TAX MAP PARCELS 32-5A, 32-37, 32-38,
32-39, 32-41, 32-45, 33-1A AND 33-8 TO THE
SCHIMINOE CREEK AGRICULTURAL AND FORESTAL DISTRICT**

WHEREAS, Criss Cross Properties, LLC has applied to add tax map parcels 32-5A, 32-37, 32-38, 32-39, 32-41, 32-45, 33-1A and 33-8, totaling approximately 1,065 acres, of which 1,065 acres have been identified as agricultural and forestal significant to the Schiminoe Creek Agricultural and Forestal District; and

WHEREAS, granting this request will increase the acreage of the Schiminoe Creek Agricultural and Forestal District from its current 3,362 acres; and

WHEREAS, this request is in accordance with state and local laws governing Agricultural and Forestal Districts; and

WHEREAS, the Schiminoe Creek Agricultural and Forestal District will expire on August 31, 2017; and

WHEREAS, this application was thoroughly considered by the Agricultural and Forestal District Advisory Committee; and

WHEREAS, after conducting a duly advertised public hearing on April 21, 2016, the Agricultural and Forestal District Advisory Committee voted 7:0:1 to forward a favorable recommendation of this application to the Planning Commission; and

WHEREAS, the Planning Commission scheduled and conducted a formal and duly advertised public hearing on June 20, 2016, in accordance with the applicable requirements of the Code of Virginia, carefully considering the public comments received and voted 9:0:1 to forward a favorable recommendation to the Board of Supervisors;

NOW THEREFORE BE IT RESOLVED this the 11th day of July, 2016, by the New Kent County Board of Supervisors, the proposed agricultural and forestal application for the addition of tax map parcels 32-5A, 32-37, 32-38, 32-39, 32-41, 32-45, 33-1A and 33-8 containing approximately 1,065 acres to the Schimineo Creek Agricultural and Forestal District is hereby approved.
