Motion was made by Mr. Davis, which carried 5:0, to adopt the following Ordinance:

**AN ORDINANCE TO AMEND SECTION 26-72 (ELECTIONS)
OF THE CODE OF NEW KENT COUNTY
TO CREATE TWO PRECINCTS AND POLLING PLACES
IN ELECTION DISTRICT 2**

WHEREAS, the Board of Supervisors of New Kent County adopted an ordinance on the 9th of October 2001 establishing election districts, precincts and polling places for the County of New Kent;

WHEREAS, only one precinct was created for Election District 2;

WHEREAS, because of high voter turnout and because the polling place was located along a highly traveled state highway, concerns for voter safety arose;

WHEREAS, the Electoral Board of New Kent County on January 12, 2004 recommended that the Board of Supervisors create a second precinct in Election District 2 with Interstate 64 being used as the dividing line;

WHEREAS, the precinct south of Interstate 64 will be called the Quinton Precinct and the precinct north of Interstate 64 will be called the Kentwood Precinct; and

WHEREAS, this division of Election District 2 into two precincts is consistent with traffic patterns and the distribution of the population

NOW THEREFORE BE IT RESOLVED by the Board of Supervisors of New Kent County pursuant to authority granted to it under Article 3 of Chapter 3 of Title 24.2 of the Code of Virginia that Section 26-72 of the Code of New Kent County be amended as follows:

Section 26-72.

(a) The names of the precincts constituting the various election districts shall be as follows:

_____ (b) _____ The boundaries of the precincts and the locations of the polling places for each are as follows:

TUNSTALL PRECINCT (District 1 north of the Black Creek)

Starting at the intersection of Black Creek and the Western County Boundary; thence along Black Creek for 9.82 miles in a easterly and northeasterly direction; thence along the County Boundary (along the centerline of the Pamunkey River) in a northwesterly direction for 4.13 miles; thence along Matadequin Creek in a southwesterly direction for 1.47 miles; thence along the County Boundary in a southerly direction for 0.63 miles to Devils Three Jump Drive; thence

along Devils Three Jump Drive in a southerly direction for 0.32 miles; thence along the County Boundary in a southerly direction for 1.01 miles; thence along Hopewell Road in a westerly direction for 1.76 miles; thence along the County Boundary in a southwesterly direction for 2.63 miles to the point and place of beginning.

All mileage given to describe the boundaries of the precincts are approximate.


Should any portion of this Ordinance be found to be in violation of the law and therefore be declared invalid by a court of competent jurisdiction, the remaining portions shall remain in full force and effect.

This Ordinance shall take effect immediately upon adoption or after the U.S. Department of Justice has notified the County that the Ordinance has received pre-clearance, whichever shall occur later.

The County Attorney shall submit this Ordinance and accompanying materials to support this Ordinance to the proper authorities for pre-clearance and notification purposes.
