**AN ORDINANCE TO INCREASE WATER AND SEWER  
RATES AND TO INCLUDE SUCH RATE CHARGES  
IN APPENDIX A  
OF THE CODE OF NEW KENT COUNTY**


**WHEREAS**, the Board of Supervisors of New Kent County received a report on September 21, 2005 from Goodman and Company on projected sewer and water system costs; and

**WHEREAS**, the Board of Supervisors determined based on these projections that the rates and charges for water and sewer connections should be increased to cover costs for constructing and maintaining the utility system and facilities.

**NOW THEREFORE BE IT ORDAINED** that, pursuant to the authority granted to it under §§ 15.2-2119, 15.2-2122 and 15.2-2143 of the Code of Virginia, Appendix A shall be amended to include the following fees:


