Motion was made by Mr. Evelyn, which carried 5:0, to adopt the following ordinance:

AN ORDINANCE TO AMEND THE
NEW KENT COUNTY
COMPREHENSIVE PLAN, *VISION 2020*,
TO INCORPORATE AN UPDATED
PUBLIC FACILITIES MAP

WHEREAS, the New Kent County Comprehensive Plan, *Vision 2020*, was adopted on August 4, 2003; and

WHEREAS, among the maps included in *Vision 2020* is a "Community Facilities Map"; and

WHEREAS, new capital projects and improvements have been made and/or proposed in New Kent County since the date of adoption; and

WHEREAS, this amendment was formally referred to the New Kent County Planning Commission in accordance with applicable procedures; and

WHEREAS, within the timeframes established by the Code of Virginia and the New Kent County Code, the Planning Commission scheduled and conducted a

formal and duly advertised public hearing on April 19, 2010 and carefully considered the amendment; and

WHEREAS, the Planning Commission voted 8:0:1 to forward the amendment to the New Kent County Board of Supervisors with a favorable recommendation; and

WHEREAS, this amendment has been advertised for public hearing before the Board of Supervisors in full accord with applicable provisions of the Code of Virginia; and

WHEREAS, approval of the amendment through the adoption of this Ordinance will further the public necessity, convenience, general welfare and good zoning practices in the County of New Kent.

NOW THEREFORE BE IT ORDAINED this, the 10th day of May 2010, by the New Kent County Board of Supervisors, that the New Kent County Comprehensive Plan, *Vision 2020*, be amended by replacing the Community Facilities Map with the New Kent County Public Facilities Map (Revised April 23, 2010).

BE IT FURTHER ORDAINED, that the County Administrator is hereby directed to have a fully executed copy of this Ordinance and attachment recorded upon the Land Records of the County in the office of the Clerk of the Circuit Court.


