IN RE: SCHOOL BOARD BUDGET FOR FY1993-94

Chairman Salmon and King called their boards to order following dinner. Mr. King, in his introductory remarks, said that the School Board has made a budget that he believes fits the educational needs of the County but realizes it must fit within the constraints of the total County budget. He also said they hope to meet the construction schedule for renovation of the Primary School. Mr. Adams explained in detail the School Board's proposed budget, which includes funding for five positions, three of which are State-mandated special education positions. It was explained that the increases in the school budget are tied to positions and salary increases. The School Board is in the second year of a four-year program to upgrade teacher salaries. Mr. Adams announced that the second Goal Setting Day on Education in New Kent County would be held on Saturday, April 3, 1993 at the High School beginning at 9:00 a.m. Following Mr. King's closing, the School Board adjourned its meeting. The Board of Supervisors continued its meeting in the Large Conference Room upstairs.
