For qualified applicants, an amount up to the previous year's average assessed value for single family homes in the locality will be exempted for that tax year per Article X, Section 6-A, subdivision (b) of the Constitution of Virginia and § 58.1-3219.9 (B). The average assessed value of dwellings for 2014 was \$170,000.
